  - b) Authorizing a person to represent the society on the General Body of NAFED, in the event of admission of your society as a member of NAFED.
2. An attested copy in English/Hindi version of the original byelaws.
3. A photocopy of the original Registration Certificate of the society as issued by the Registrar Coop.Societies.
4. A copy of the Annual-Report in English/Hindi version duly audited by the Charatered Accountant for the last cooperative years preceeding the date of the application.
5. A copy of the Trading Account duly audited by the Charatered Accountant for the preceeding last two years.
6. In case, the statutory audit of your society for the previous year has not been completed, a copy of the trading account in English/Hindi version duly certified by the Registrar Cooperative Societies of your State may please be sent.
7. A Demand Draft of Rs.1,01,000.00/-(**Rupees One Lac One Thousand Only**) towards value of share(s) @ Rs.25000/- or Rs.2500/- per share as applicable including admission fee of Rs.1000/- favouring National Agricultural Cooperative Marketing Federation of India Limited (NAFED) payable at New Delhi.

## GUIDELINES FOR MEMBERSHIP OF NAFED

The following societies are eligible for membership of Nafed. The relevant provisions of byelaws are reproduced as under:

### 1. **ELIGIBILITY:**

The Board of Nafed in their meeting held on 11.12.2009 decided that only such Primary Cooperative Societies/Federations will be enrolled as member of Nafed who fulfill the following criteria:-

1. **Societies seeking the membership should primarily deal in the marketing and processing of agricultural commodities as per byelaw.**
2. **Should be of Block Level and above. A certificate should be obtained from the Registrar.**
3. **In addition, the respective Branch Manager should verify membership applications.**

BYE-LAW 4(a) The membership of NAFED shall consist of the following categories:

**4a (iv) 1.** The minimum sales turn over of Rs.50 lacs may be prescribed for admission of members under byelaw 4a (iv).

**4a (iv) 2.** The minimum share capital to be contributed by the Primary Society as well as Apex Level Union Territories shall be Rs. 50,000/- for North Eastern States including Sikkim and Rs. 1,00,000/- for other States/Uts.

**4a (iv) 3.** The minimum share capital to be contributed by State Level Commodity Federations and other Organisation eligible for membership under bye law 4a (iii) shall be Rs.2,50,000/-for North Eastern States including Sikkim and Rs.5,00,000/-for other States/Uts.

**4a (iv) 4.** The minimum share capital to be contributed by State Level general purpose cooperative marketing federation shall be Rs.50,00,000/- for other States/Uts.In the case of North Eastern States including Sikkim, the contribution shall be Rs.7,00,000/-.

5. **Government of India.**

6. **The minimum share capital to be contributed by National Cooperative Consumers federation of India Ltd. and any other National level Cooperative Organization shall be Rs.2,00,00,000/-.**

### **Bye-law 4(c) Nominal *Membership Fee*:**

Such other persons/societies/institutions not covered by bye-law 4(a) above, with whom the NAFED is likely to do business or store goods, or arrange sale thereof, provided the application for admission to such membership is received alongwith the **admission fee of Rs.5,00,000/-** and is duly accepted by the Board of Directors, may be admitted as nominal members. Such admission fee shall not be refundable in any case. Such members will, however, not carry right to vote or participate in the management of the Federation or in the sharing of its profits or liabilities.

### **Admission Fee & Share Capital**

6. Every member other than a nominal member shall pay Rs.1000/- as admission fee, which shall not be refunded in any case.

12(b) The authorized share-capital of the Federation shall be Rs.100 crores consisting of:

(b)(i) 30000 shares of Rs.25,000/- each to be subscribed by the members categorized under byelaw 4(a)(i), (iii), (v), (vi), (vii) and (viii).

Subscription to be allowed to members categorized under byelaw 4(a)(ii) and (iv)(1) in case that category is fully subscribed.

(b)(ii) 1,00,000 shares of Rs.2,500/- each to be subscribed by the members categorized under byelaw 4(a)(ii) and (iv)(1).

Subscription to be allowed to members categorized under byelaw 4(a)(i), (iii), (v), (vi), (vii) and (viii) in case that category is fully subscribed.

Provided 1721 shares of Rs.1,000/- each and 34 shares of Rs.5,000/- each already issued shall not be disturbed and shall not effect the total of the authorized share capital.

### **Liability**

13. In the event of liquidation, the liability of the shareholders for any deficit in the assets of NAFED shall be limited to the share capital subscribed by them.
