("NAFED") having its head office at NAFED House, Siddhartha Enclave Ring Road, Ashram Chowk, New Delhi-110014 and the concerned branch office at NAFED GUJARAT Nafed A wing 6 th floor Maradia Plaza CG Ahmedabad Gujarat, will obtain all adequate licenses/permissions for such auctions being conducted on Praman and will be organizing the auction under applicable laws.

# 1. User Registration and Eligibility to use

- Praman and the Services are addressed and made available to any person or entity.
- Any person or entity wanting to access or use Praman to participate in auctions will firstly need to register on Praman to become a User of Praman ("User").
- To become a User and participate in the Auction on Praman ("Auction") and avail of the Services, a person shall be required to submit specified details (may be amended from time to time as per Praman's discretion) to meet the registration requirements as also listed on Praman platform and/or App, which requirements shall include:
  - a. <u>For individuals/proprietorship firms</u>: a PAN card or an Aadhar card (as applicable), copy of the GST registration certificate if applicable, verified contact number, email address, copy of a canceled bank cheque, and any other information or documents needed by us at the time of registration;
  - b. <u>For incorporated/registered entities</u>: a PAN card, details of the nature of the entity (e.g, LLP, company, etc.), copy of the GST registration certificate, copy of the certificate of incorporation or registration (as applicable), charter documents, copy of a canceled bank cheque, address proof of the entity and contact number(s) of the entity registering to become a User.
- Registration shall be completed and submitted only by an authorized representative or any other person with legal authority to bind the entity which is applying to become a User ("Authorized Representative") and such persons shall be required to provide their name, Aadhar card copy, or any government-issued identity proof, contact number, email address and a copy of the authorizing board resolution, power of attorney or any other document on the letterhead of the entity conferring the authority on the individual to act on behalf of the entity concerning Praman and/or the Services.
- Praman has the sole and absolute discretion whether to accept an individual and/or corporate entity as a User. Praman reserves the right to reject any application for registration, without giving reasons or cause. The applicant hereby authorizes Praman to

### 2. Earnest Money Deposit

- An Earnest Money Deposit ("EMD") of Rs 5000/- (Rupees Five Thousand Only) would be
  made towards Praman against each auction by the User in which the User participates
  and would be refunded back if the User is not the highest bidder within 10 days from the
  date of the Auction. This EMD amount is subject to change as per the discretion of Praman
  and/or NAFED and any change would be intimated to the User and updated on these
  Terms of Use accordingly.
- If a User defaults one (1) time in payment of the final amount, if different from Deposit after the bid has been accepted, the User shall be prohibited from participating in the auction process.
- Further, this EMD made towards Praman to participate in the auctions will not accrue any
  interest and there would be no claim admissible against Praman in respect of interest on
  EMD at the time of its release.

#### 3. Pre-Auction

- The schedule of the auction will be shared by Praman with NAFED prior to the auction.
- NAFED would approve the auction schedule and will inform the concerned FPO accordingly, and ensure the material is made available. If NAFED disapproves of the auction schedule, Praman will reschedule it and make another request for approval from NAFED.
- Once the schedule is approved by NAFED via Email or SMS, the auction will be conducted.
- Concerned FPC will ensure the auction material is ready and kept aside for the auction, failing which the auction will be cancelled. Kindly refer to Clause 11 (Quality Specifications for Onions) for Grade-B onion quality specs.
- Concerned FPC will ensure demarcation of the same via chalk
- Quality Reports of the Auction material will be made available on the Platform within 24 hours of the auction material being made available to Praman by the concerned FPO. These reports will be published on the auction platform before the Auction is conducted and made available in the Auction details.
- Quality Reporting will be done by Praman at the location, before dispatch ("Dispatch Location") to the warehouse location where the material will be made available to the Successful Bidder as also mentioned in the Auction details.

 FPC will provide the Sauda Patti of last Grade B sold in mandi by the concerned FPC for the reference price .Praman will share the Sauda Patti with NAFED

#### 4. Auction

- The Auction would be conducted on Praman at <u>auction.praman.ai</u> daily from 1200hrs to 1400hrs or as decided by Praman and NAFED, if any other time is decided, the intimation of the same would be given to the Users of Praman via a SMS, Email or Phone call.
- If there is a higher bid in the last 5 minutes of the Auction, the Auction would get extended by 5 minutes subject to a maximum of 1 extension. *Illustration: If the auction was to end at 1215hrs but at 1214hrs or 1215hrs another higher bid is received the auction can be extended to 1220hrs.*
- All the Users who have registered for the Auction would be given access to the Auction as per the time decided.
- Users would bid for the selected auction and can revise their bids upward.

### 5. Winning Bid

- NAFED's Branch Level Committee would approve or reject the bid winner after the final bid is made. NAFED would confirm the same to Praman by 1500hrs/3 PM or as decided by NAFED on the auction day.
- If the Bid is rejected, NAFED will mention the reason for the same:
  - a. Low Price;
  - b. Less Bidders; or
  - c. Others (Explanation required by NAFED).
- The successful Bidder will be notified of the same via notification on the auction platform or E-mail or SMS or Phone Call.

#### 6. Post Auction

Post-approval from NAFED, if the bid is approved the Successful Bidder would be asked
to deposit the estimated bid amount along with the Service Fees (collectively referred to
as "Deposit") mentioned below in Clause 7 (Service Fee), on the same day of the auction
by 1300hrs/3 PM. Details for making the Deposit would be made available to the

- Successful Bidder in the notification sent via SMS or Email or via Phone Call and cash is not an acceptable mode of payment.
- If the User is not able to make the Deposit on the same day by 1800hrs/6 PM, the EMD will be forfeited by Praman.

## 8. Quality Parameter/Inspection of material

- The quality of the material for sale is on "as is where is basis". The Users should visit the warehouses for inspection of material before participating in the auction and by giving prior intimation to Praman about such a visit.
- The User shall be solely responsible for inspecting the material before participating in the auction.

### 9. Payment & Collection of Material

- As per the auction estimated quantity, the Successful Bidder will make the Deposit to Praman as mentioned in Clause 6 (Post Auction).
- The Successful Bidder will be given the estimated tax invoice for the Auction Service Fee as per the estimated quantity..
- After confirmation of payment by Praman of the final amount by the Successful Bidder,

- NAFED will share the Delivery order ("**Delivery Order**" with Praman after receiving the transaction details, which will be shared with the successful Bidder and FPC via email.
- The Successful Bidder will bring the Delivery Order to the location as provided in the Auction details or as intimated to the User after making the Deposit for collection of the Auction material.
- Concerned FPC needs to provide the labour as per availability for loading the auctioned material within 20 hours, so that material can be picked within 24 hours of the Delivery Order.
- Labour Charges for filling in the gunny bag or loading loose material onto the vehicle will not be borne by the Successful Bidder.
- Any other charges (such as but not limited to gunny bag loading, weighing, sealing of bags) will only be managed directly by the concerned FPC and the Successful Bidder.

- Praman will share the DC, DO, weightslip and payment details to NAFED and the concerned FPC via email within 72 hours
- NAFED will issue the Material Invoice accordingly as mentioned in the final weight slip.

# 10. Quality Specifications of Onion

- Grade B:
  - a. The following defects are acceptable as part of Grade B:
    - Black Smut;
    - Sprouting;
    - SunBurn;
    - Half skin out;
    - Cuts and Cracks;
    - Jod; or
    - Skin out
  - b. The following defects are not acceptable as part of Grade B:
    - Wet Onion; or
    - Rotten.
- Grade C:
  - a. The defects are acceptable as part of the Grade C:
    - Wet Onion;
    - Rotten; or
    - Layers of Onion

# 11. Downtime and Force Majeure

- User may not be able to access or use Praman and/or the Services:
  - a. during planned downtime for upgrades and maintenance to Praman and the Services (of which Praman will use commercially reasonable efforts to notify Users in advance);
  - b. during any unavailability caused by circumstances beyond reasonable control, such as but not limited to, acts of God, acts of government, acts of terror or civil unrest, technical failures beyond Praman's reasonable control (including, without limitation, inability to access the internet), or acts undertaken by third parties, including, without limitation, distributed denial of service attacks ("Force Majeure Event"). Each User acknowledges that in the event of Force Majeure Event, Praman and NAFED shall be relieved from respective obligations (or part thereof) as long as the Force Majeure Event hinders the performance of said obligations (or part thereof). Praman will make reasonable efforts to mitigate the effects of the Force Majeure Event.

# 12. Applicable Law & Dispute Resolution

• The provisions of these Terms of Use shall be governed by and construed in accordance with Indian law. Any dispute relating to these Terms of Use or in respect of any rights, liabilities, and obligations arising out of these Terms of Use shall be resolved between the Parties in an amicable manner by discussions between the senior management team of the Parties. However, if any such disputes stand unresolved, such disputes will be resolved through arbitration through 3 (three) arbitrators out of which 1 (one) arbitrator would be appointed by each of the Parties and the 3rd (third) arbitrator mutually by both the arbitrators as appointed by the Parties. The arbitration proceedings shall be carried out in accordance with the provisions laid down by the Arbitration and Conciliation Act, 1996, and the place of arbitration shall be in Gurgaon, India. The arbitration proceedings shall be conducted in the English language.

#### 13. Limitation of liability

- Praman is only a facilitator and is not and cannot be a party to or have control in any manner any auction, advertisement, exhibition, making available, offer to sell products on Praman, or any transactions of sale or purchase of products executed between the User and NAFED or FPO.
- To the maximum extent mandated by law, Praman will not be liable to the User and/or NAFED and/or FPO for any lost profits or business opportunities, for loss due to the

auctions being held on Praman, loss of use, loss of revenue, loss of goodwill, business interruption, loss of data, or any other indirect, special, incidental or consequential damages under any theory of liability, whether based in contracts, torts, negligence, product liability, or otherwise.

Praman's liability, if any, arising out of or in connection with these Terms of Use will not
exceed the Service Fees paid by the User for the specific auction which gives rise to such
cause of action. For any third party claims, other than those related to the auction, the

• Use of third Parties for Payment Processing: Praman may use a third party service ("Payment Aggregator"), to manage payment processing; provided that such service,

- Praman is not permitted to store, retain, or use the User payment account information except to process the User payment information for Praman.
- Entirety: These Terms of Use, constitute the entire agreement and supersede any and all
  prior agreements between the Parties relating to the subject matter. Praman may amend
  these Terms of Use from time to time in which case the new Term of Use will supersede
  prior versions. The Users are to read these Terms of Use carefully before using Praman
  and its services.
- Severability: If any provision in these Terms of Use is held by a court of competent
  jurisdiction to be unenforceable, such provision shall be modified by the court and
