ORDER

Whereas, ANS GROUP had participated in Wheat e-auction under OMSS (D) dated 21.02.2024 at the M junction portal and the party was allotted 50 MT of URS Wheat stock from FCI, PEG, Kishanganj under FCI, Divisional Office, Purnia at bid price of Rs. 2235/- per qtl.. During verification of documents which were provided by the said party , it was found that he had provided electricity bill which was in the name of some other mill. After finding this anomaly, that is a violation of MTF provisions, the said bid was not approved on the portal.

Whereas, a Notice dated 14.03.2024 was issued to ANS GROUP by the Regional Office vide letter no RO BR-15.0011.0/5/2024-COMM - RO BR dated 14.03.2024 on the ground of violation of MTF provisions. In response to this notice, firm had submitted reply which was not satisfactory.

Therefore, in exercise of point no. (14) of Undertaking/ Appendix-IV of MTF "In case of event of any information found incorrect at any point of time, the party would be debarred for a period of (1) one year from participating in any e-auction under OMSS (D).

Accordingly, the EMD amount of Rs. 53,125/-, which is 5% of total cost of the stock(Reserve Price of stock was Rs.2125/Qtl.) of 50 MT (Wheat-URS) purchased is forfeited and ANS GROUP is hereby debarred from participation in the E-Auction for the Open Market Sale Scheme (Domestic) {OMSS (D)} for a period of one year from the date of issue of this order.

This debarment order shall take effect immediately upon date of issue of the order and the firm is instructed to comply with this order and cease participation in any relevant activities during the specified debarment period.

If bidder is not satisfied/still aggrieved with the decision, an appeal lies to FCI, ED (EAST) (edeast.fci@gov.in).
