# NAFED Invites Applications from the Eligible PACS/FPO/FPC for the Opening of NAFED Bazaar Franchisee Stores Under the International Year of Cooperatives 2025

NAFED is the apex level organization of Agricultural Marketing Cooperatives in India to organize, promote and develop marketing, processing and storage of agricultural, horticultural and forest produce, distribution of inputs and to undertake inter- state and export of agricultural produce. NAFED is also a Central Nodal agency for procurement of notified agricultural commodities under Price Support Scheme (PSS) on behalf of Govt. of India. NAFED also procures Pulses for Buffer Stocking under Price Stabilization Fund (PSF) Scheme of the Government of India. Nafed also deals in retail and consumer marketing through its Consumer Marketing Division.

NAFED is engaged in the operation of the retail outlets under the name and style of "NAFED Bazaar" with the intended objective of increasing its presence in the retail consumer market segment by providing NAFED-branded products and other products in retail to the consumers at competitive rates.

The UN's International Year of Cooperatives- 2025 (IYC-2025), themed "Cooperatives Build a Better World", was officially launched on 25th November 2024 during the ICA Global Conference in New Delhi. The ceremony was graced by the Hon'ble Prime Minister, Shri Narendra Modi and Hon'ble Union Home Minister and Minister of Cooperation Shri Amit Shah. During the event, the Hon'ble Prime Minister emphasized the role of cooperatives in fostering sustainable growth.

The Hon'ble Union Home Minister and Minister of Cooperation, Shri Amit Shah also put forth his views and highlighted that through the IYC-2025, the Hon'ble Prime Minister's clarion call for "Sahkar Se Samriddhi" can be achieved in the coming times, which will pave the way for the prosperity of millions of villages, women and farmers.

Under the flagship initiative of the International Year of Cooperatives (IYC) 2025, Nafed has planned to establish 500 Nafed Bazaar Stores across India, in collaboration with Primary Agricultural Credit Societies (PACS), Farmer Producer Organizations (FPOs), and Farmer Producer Companies (FPCs), with the objective of strengthening and empowering cooperative entities and the member societies.

#### **NAFED's Requirement**

National Agricultural Cooperative Marketing Federation of India Ltd. (NAFED) invites applications from Eligible FPOs/PACs/FPCs for Opening of NAFED Bazaar Retail Stores, with a view to expand its presence in retail sector and promote and support PACs, FPOs and FPCs in establishing and operating NAFED Bazaar Franchisee stores across the country.

#### **Minimum Eligibility Criteria**

Note-All the above-mentioned documents are to be duly signed and stamped by the applicants.

#### **Important**

1. The Successful Applicant/Franchisee Store Partner shall submit an interest-free security by way of BG/DD of Rs. 50,000/- per NAFED Retail Store to NAFED to secure its obligations under this document. Subject to compliance with the terms and conditions of this document, the Security Deposit shall be refunded without any interest after 30 days of completion/termination of the Service Level Agreement. In the event of non-payment of any bills raised by NAFED or non-performance of any terms and conditions or to satisfy any claims of NAFED under this document, NAFED shall be entitled to forfeit such interest-free security.

- 2. Nafed shall approve the list of permitted products for retail sale through Nafed Bazaar Franchisee stores. Sale of prohibited items like Tobacco, cigarettes, Liquor, etc, will not be allowed from Nafed Bazaar Franchisee stores.
- **3.** The NAFED Bazaar Stores shall be equipped with POS equipment and SAP software for proper collection and analysis of data. Cash as well as digital sales shall be allowed, and all transactions must be recorded through the POS system.
- **4.** Franchisee Partner shall not obtain any loan or cash/credit facility from Bank or financial institution against the store or stocks of store.
- 5. A separate Bank account shall be opened for the business in which the Franchisee partner shall deposit cash and maintain a sales account. Bank statements tallying with SAP/ERP reports to be submitted to Nafed.
- **6.** The Franchisee Partner shall be required to ensure that all products supported by cooperatives or Farmer Producer Organizations (FPOs), such as Amul and similar entities, as may be facilitated, directed, or mandated by NAFED, are mandatorily made available, offered, and sold through the respective Franchisee Nafed Bazaar stores to the customers.
- 7. The Franchisee Partner shall be required to ensure that all products supported under Government of India initiatives and schemes, as may be facilitated or mandated by NAFED, including but not limited to Bharat Brand products and horticulture initiatives such as the sale of onions under the Price Stabilization Scheme, are mandatorily made available, offered, and sold through the respective Franchisee Nafed Bazaar stores to the beneficiaries/customers.
- **8.** PACS/FPOs/FPCs with a minimum area of 100 Sq.ft. will be given preference.
- **9.** Nafed shall be paid by the Franchisee partner, a certain percentage of sales turnover of the respective NAFED Bazaar Stores on monthly basis.
- 10. The Franchisee Partner will strictly abide by all statutory rules and regulations including obtaining license/permit etc. if any required to run the business from the said premises. All rules and regulations pertaining to compliances of MCD or Local Governing Body shall be observed and complied in latter and spirit by the Franchisee Partner and any burden on NAFED on account of such violation on the part of Franchisee Partner, same shall be borne by the Franchisee Partner at its risk and cost.
- 11. Product placement: Emphasis will be made on keeping the product range as per business requirement of the franchise partner store.
  - (i) Not less than 20% of the stock shall be from Nafed brand products.
  - (ii) Preference shall be given to Nafed branded products and all varieties of Nafed branded products are to be kept at all Franchisee Partner stores without any fail.
- **12.**A Service Level Agreement will be executed with the successful applicants post onboarding process. The Service level agreement will be valid for a period of 9 years.
- **13.** Any other required formalities/documents shall be communicated by the respective state branch of Nafed.

Interested FPOs/PACs/FPCs that meet the above-mentioned criteria can submit their application along with hard copies of all required documents/profile and all annexures (duly filled, signed and stamped), by Post/Courier or by Hand to the concerned state branch of Nafed. thereof, be deemed to mean and include its representatives, nominees, affiliates, successors

#### **PREAMBLE**

And

- **B.** In order to achieve these goals, the Principal will appoint Independent External Monitors (IEMs) to monitor the process and the execution of the contract with the applicants/bidders/contractors/vendors for compliance with the principles mentioned in this Integrity Pact.

#### **Article: 1- Commitments of the Principal**

- 1. The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles:
  - a) No employee of the Principal, personally or through family members, will in connection for, or the execution of a contract, demand; take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
  - b) The Principal will, during the process treat all Applicant (s) / Bidder (s) with equity

and reason. The Principal will in particular, before and during the process, provide to all Applicant (s) / Bidder(s) the same information and will not provide to any Applicant (s) / Bidder(s) confidential/additional information through which the Applicant (s) / Bidder(s) could obtain an unfair advantage in relation to the process or the contract execution.

- c) The Principal will exclude from the process all known prejudiced persons.
- 2. If the Principal obtains information on the conduct of any of its employees which is a criminal offence under the IPC/PC Acts, or if there be a substantive suspicion in this regard, the Principal will inform the Chief Vigilance Officer and in addition can initiate disciplinary actions.

#### Article: 2 – Commitments of the Applicants (s) / Bidders(s)/Contractor(s)

- 1. The Applicant (s) / Bidder(s)/Contractor(s)/Vendor(s) commit themselves to take all measures necessary to prevent corruption. The Bidder(s)/Contractor(s) /Vendor(s) commit themselves to observe the following principles while participating in the process and during the contract execution.
  - a) The Applicant (s) / Bidder(s)/Contractor(s)/Vendor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal's employees involved in the process or the execution of the contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the process or during the execution of the contract.
  - b) The Applicant (s) / Bidder(s)/Contractor(s)/Vendor(s) will not enter with other Applicants / Bidders into any undisclosed agreements or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
  - c) The Applicant (s) / Bidder(s)/Contractor(s)/Vendor(s) will not commit any offence under the relevant IPC/PC Acts; further the Applicant (s) / Bidder(s)/Contractor(s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
  - d) The Applicant (s) / Bidder(s)/Contractor(s)/Vendor(s) of foreign origin shall disclose the name and address of the Agents/representatives in India, if any. Similarly the Applicant (s)/Bidder(s)/Contractor(s) of Indian Nationality shall furnish the name and address of the foreign principals, if any. Further details of Indian Agents of Foreign Suppliers shall be disclosed by the Applicant (s) / Bidder(s)/Contractor(s)/Vendors. Further, all the payments made to the Indian agent/representative have to be in Indian Rupees only.
  - e) The Applicant (s) / Bidder(s)/Contractor(s)/Vendor(s) while presenting their bid, will disclose any and all payments made, are committed to or intend to make to agents, brokers or any other intermediaries in connection with the award of the contract.
  - f) Applicant (s) / Bidder(s)/Contractor(s)/ Vendor(s) who have signed the Integrity Pact shall not approach the Courts while representing the matter to IEMs and shall wait for their decision in the matter.
- 2. The Applicant (s) / Bidder(s)/Contractor(s)/Vendor(s) will not instigate their persons to commit offences outlined above or be an accessory to such offences.

#### Article: 3 – Disqualification from the empanelment process and exclusion from future contracts

If the Applicant (s) / Bidder(s)/Contractor(s)/Vendor(s), before award or during execution has committed a transgression through a violation of Article 2, above or in any other form such as to put their reliability or credibility in question, the Principal is entitled to disqualify the Applicant (s) / Bidder(s)/Contractor(s) from the empanelment process or take action as per the laid down procedure.

#### **Article: 4- Compensation for Damages**

- 1. If the Principal has disqualified the Applicant (s) / Bidder(s) from the empanelment process prior to the award according to Article 3, the Principal is entitled to demand and recover the damages equivalent to Earnest Money Deposit/Bid Security.
- 2. If the Principal has terminated the contract according to Article 3, or if the Principal is entitled to terminate the contract according to Article 3, the Principal shall be entitled to demand and recover from the Contractor/vendor liquidated damages of the Contract value or the amount equivalent to Performance Bank Guarantee.

#### **Article: 5 – Previous transgression**

- 1. The Applicant / Bidder declares that no previous transgressions occurred in the last three years with any other firm/Company/organization in any country conforming to the anti-corruption approach or with any Public Sector Enterprise in India that could justify its exclusion from the empanelment process.
- 2. If the Applicant / Bidder makes incorrect statement on this subject, he can be disqualified from the empanelment process or action can be taken as per the procedure mentioned in "Guidelines on Banking of business dealings".

#### Article: 6 -Equal treatment of all Applicants / Bidders / Contractors /Subcontractors

- 1. In case of Sub-contracting, the Principal Contractor shall take the responsibility of the adoption of Integrity Pact by the Subcontractor.
- 2. The principal will enter into agreements with identical conditions as this one with all Applicants/Bidders and Contractors.
- **3.** The Principal will disqualify from the empanelment process all applicants/bidders who do not sign this Pact or violate its provisions.

# Article: 7 - Criminal charges against violating Applicant (s) / Bidder(s) / Contractor(s) / Subcontractor(s)

If the Principal obtains knowledge of conduct of a Applicant/Bidder, Contractor or subcontractor, or if an employee or a representative or an associate of a Applicant/Bidder, Contractor or Subcontractor which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principal will inform the same to the Chief Vigilance Officer.

#### **Article: 8 - Independent External Monitor**

1. The Principal appoints competent and credible Independent External Monitor for this Pact after approval by Central Vigilance Commission. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the

obligations under this Integrity Pact.

- 2. The Monitor is not subject to instructions by the representatives of the parties and performs his/her functions neutrally and independently. The Monitor would have access to all Contract documents, whenever required. It will be obligatory to him /her to treat the information and documents of the Applicants / Bidders / Contractors as confidential. He /she will report to the Managing Director, Nafed.
- 3. The Applicants / Bidder(s)/ Contractor(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the Principal including that provided by the Contractor will also grant the Monitor, upon his/her request and demonstration of a valid interest, unrestricted and unconditional access to their project documentation. The same is also applicable to Sub- contractors.
- 4. The Monitor is under contractual obligation to treat the information and documents of the Applicants / Bidder(s)/ Sub-contractor(s) with confidentiality. The Monitor has also signed declarations on 'Non- Disclosure of confidential Information' and of 'Absence of Conflict of interest '. In case of any conflict of interest arising out at a later date, IEM shall inform the Managing Director, Nafed and recues himself/herself from that case.
- 5. The Principal will provide to the Monitor sufficient information about all the meetings among the parties related to the Project provided such meetings could have any impact on the contractual relations between the Principal and the Contractor. The parties offer to the Monitor the option to participate in such meetings.
- 6. As soon as the Monitor notices, or believes to notice, violation of this agreement, he/she will so inform the management to discontinue or take corrective action, or to take relevant action. The monitor can in this regard submit non-binding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.

The Monitor will submit a written report to the Managing Director, Nafed within 8 to 10 weeks from the date of reference or intimations to him by the Principal and, should the occasion arise, submit proposals for correcting problematic situations.

If the Monitor has reported to the Managing Director, Nafed, a substantiated suspicion of an offence under relevant IPC/PC Acts, and the Managing Director, Nafed has not, within the reasonable time taken visible action to proceed against such offence or reported it to the Chief Vigilance Officer, the Monitor may also transmit this information directly to the Central Vigilance Commissioners.

The word "Monitor" would include both singular and plural.

#### **Article: 9 – Pact Duration**

This pact begins when both parties have legally signed it. It expires for the Contractor 12 months after the last payment under the contract, and for all other Applicants / Bidders 6 months after the contract has been awarded. Any violation of the same would entail disqualification of the applicants/bidders and exclusion from future business dealings.

If any claim is made/lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/determined by the Managing Director, Nafed.

#### **Article: 10 – Other provisions**

This agreement is subject to Indian Laws. Place of performance and jurisdiction is the Registered Office of the Principal, i.e. New Delhi.

Changes and supplements as well as termination notices need to be made in writing.

If the contractor is a partnership or a consortium, this agreement must be signed by all partners or consortium members.

Should one or several provisions of this Integrity Pact turn out to be invalid, the remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement to their original intentions.

Issues like Warranty/Guarantee etc. shall be outside the purview of IEMs.

In the event of any contradiction between the Integrity Pact and its Annexure, the Clause in the Integrity Pact will prevail.


